Fees:

- Outdoor Storage: \$2.00 per foot/ per month**
- Outdoor Storage Trailer when in slip: \$1.00 per foot/ per month**
- Indoor Storage: \$2.50 per foot/ per month**
- Slip Storage: \$3.50 per foot/ per month**

Marina Policies

Requesting Storage: Patron requesting storage must be eligible according to AR 215-1 (Active Duty, Retired Military, DOD Civilian, Full Time Contractor on APG and 100% Disabled Veteran). Registration, Insurance and proof of eligibility must be provided at the time request form is filled out and sent via email to usarmy.APG.imcom-fmwrc.list.usag-mwr-outdoorrec@army.mil . **PERSON ON APPLICATION FORM REQUESTING SPACE MUST BE THE OWNER OF VEHICLE BEING STORED.** Once submitted patron will receive a call for payment or to be placed on a waitlist. Patron will be assigned a space in one of our Marinas (Aberdeen or Edgewood).

Deposit Storage Fees and Billing: Storage registrations go by a calendar year, 1 January to 31 December. Patrons have payment options of Annually, Monthly, Semi-Yearly or Quarterly. Annually payments are due by the 1st of the year. Any other billing payments will be ran on the 1st of the month, credit cards must be provided for automatic billing. Patrons are responsible to update credit card information if expired or compromised. LATE FEES begin on the 7th of the month, patron is subject to \$20.00 late fee and additional \$5.00 per day after.

Cancelling Storage/ Abandoning Vehicles: Patrons storage can be cancelled by sending in the request via **email** and stating when/if they remove. MWR Staff will check to make sure vehicle is removed and space is in the manner that it was issued in. At that time the deposit will be refunded.

Refunds can be issued if paying annually for the months that storage will not be used. Vehicles that are stored with us that are 45 days past due will be subjected to the abandoned process which includes late fees, certified letters and property being removed from space. The personal property will be returned to patron upon payment of all fee and late fees.

Renewal Process: Reminder emails will go out in mid-October to remind patrons to renew. Submission of registration, insurance and eligibility are due at this time. Credit Card numbers will have to be provided at this time to be relinked to the new bills at this time.

ALL Space Storage Policies: MWR Staff will complete monthly inspections to make sure spaces are neat and do not have unsightly debris such as ripped tarps, trash and etc. around the vessel, along with tags and boat registration are compliant with the state registrations.

- Boat owners are to maintain boats and storage area in good order and appearance. MWR reserves the right to deny storage to persons with un-seaworthy vessels, uninsured vessels, vessels in poor appearance, and/or poor condition. All boat trailers stored must be road worthy at all times.
- Personal property is not to be stored outside of the registered. This includes no dock boxes all items must be store on the vessels.
- **All boats must be marked with patrons name visible to staff. MWR reserves the right to move your boat if needed for operations of the marina. NO LOCKS ON BOAT HITCHES.**
- NO maintenance or cleaning boats with chemicals are prohibited while at the marinas.
- Live a-boards are not permitted at any Marina at APG. A live a-board is defined as a person(s) using a vessel as a residence or overnight accommodation between 2200 and 0500 for more than two days out of seven maximum per month. Patron's found to be in violation of this policy may lose all rights and privileges as a registered storage user of the Marinas at APG

Daily Parking: Patrons and guest of patrons are permitted to park in the daily parking from dawn to dusk. Cars left over night will be ticketed by APG Police Department.

Piers: Patrons are not permitted to attach any permanent or detachable fixtures to the piers.

Pertaining to Edgewood Marina:

Fuel: All DOD ID Card holders who are boating are permitted to purchase fuel at the pumped located at Edgewood Marina (Gunpowder Neck Marina). Fuel can be purchased and pumped during advertised hours staffed by MWR volunteers. All fuel sales and fuel services must be recorded on the fuel log with the volunteer. The current methods of payments are check or card. The price of fuel is based on the sale price of the last delivery from the vendor.

FUEL SPILL EMERGENCY PROCEDURE

- Turn off fuel pump/emergency stop button
- Dial 911 report fuel spill and location immediately to Fire department
- Deploy spill control booms located at fuel pump
- Turn off all bilge pumps on boat being fueled e. Alert other boats in close proximity to spill
- Call ODR Business Manager and Facilities Manager to inform them of spill.
- Fire department will notify Coast Guard/EPA if deemed necessary. i. 2 drops spill is not required to be reported.
- All containment waste must be disposed of offsite in Hazmat containers
- Do an after action report combined with fire department report and submit to ODR

Indoor Warehouses: Year round patrons are asked to park towards the back of the warehouse due to seasonal patron removing in early April. Patrons that want to come out before 30 April are asked to be one of the last to go in the warehouse.
