2. Information

- a. Parent/ Child lessons are completed in 3 classes.
- b. Parent/ Child lessons are separated into two age groups. (6 months to 2 years and 2 years to 4 years)
- c. Parents are responsible for reporting all physical and medical disabilities of their children to ensure instructor ratio is accurate.
- d. All classes will consist of 30 minutes of class time.

3. General Policies

- a. All participants must arrive to class on time.
- b. No talking to Swim Instructors or Lifeguards during swim class. All questions can be asked before or after
- c. Parents are required to stay in the pool facility while their children are in lessons.
- d. On the last day of class participants will obtain a certificate.
- e. If there is a bugle call during swim lessons the instructor will clear the pool. Classes will pause during the bugle call.

4. Inclement Weather/ Pool Contamination Policy

- a. Lessons will be canceled the event of thunder, lightning, heavy rain or pool contamination that occur 15 minutes before the start of swim lesson.
- b. If thunder, lightning, heavy rain or pool contamination occurs during the swim lesson:
 - 1. During the first 15 minutes: the lesson will be rescheduled for the make-up day.
 - 2. Participants will be notified of cancelled classes via email or phone.
 - 3. Make-up dates will be held on the next available day not scheduled. Additional dates will be scheduled as needed. Please ask an instructor if you are unclear of your class makeup dates.

5. **Refund Policy**

- a. We do not provide credits or refunds for missed classes.
- b. Credits will be given if APGMWR has to cancel class do to chemicals, fecal matter, vomit, etc., and only if a make-up class cannot be scheduled.
- c. All cancellations must be 2 business days prior to the start of the class.
- d. Refunds due to a medical reason must be accompanied by a doctor's note in order for fees to be refunded.
- e. Please communicate with the swim instructors or Recreation Central Staff to find out any make-up class dates and times. Make up classes will be the following week between sessions.
