

# Army Child Youth Services Fees

**SY 2025-2026**



The Army Fee Charts listed below are in line with OSD Policy. Fee charts are included for Standard, Low Cost and High Cost. While a twelfth fee category was added for those whose TFI exceeds \$175,001, Categories 1-11 remain the same with no fee increase.

The Army has retained the fee charts for Full Day 4-Year-Old Pre-Kindergarten and there have been no changes to the process for care with this population. ***\*\*This service may not be available at all installations and is not a program requirement.***

- The Before and After School Care rates will be utilized during the school year. During the Summer, they will pay the full-day CDC rate.
- If your CYS does provide transportation, a transportation fee may be charged/asses for this service, which is in addition to child care fees. Some aspects that you will note:

## **Other Notes for 2025-2026:**

- Not more than one discount may be used per child at one time. (stacking and combining discounts is prohibited). If a family is eligible for more than one discount, they will need to decide while discount they prefer to have applied.
