APG 2020-2021 Hunting Season

During the current public health crisis COVID- 19 the below **GUIDELINES MUST BE ADHERED TO** for public safety while participating in the APG Spring Bearded Turkey Season.

Guidelines

Hunters entering the Installation through Maryland Gate or Hoadley Gate will need to show proper Identification and APG hunting permit for access.

Social Distancing will be practiced at all times.

Remain six (6) feet or more from other individuals.

No Hunters will be allowed in the APG North or APG South Hunting Management Facilities (HMF) including cold boxes.

(**Note**: The only exceptions is for the HIC's who need to sign for a key to access the areas at Graces Quarters, Carroll Island, and Nike site locations. This will be limited to one HIC at a time and mask and gloves are required.)

Signing in and out at the HMF's will be performed by the Hunter in Charge (HIC) who has received the hunting area. (NOTE: HIC's will not be required to stop and sign access roster at the security area gates)

(Note: 1. When a Hunter is signing in and out and recording harvest data will be conducted one at a time, each will use their own pen, and will wear a mask and gloves. (NO LINES)

2. HIC's will remain in their vehicles until the previous HIC returns to their vehicle.

3. All other HIC's and guests in the hunting party will remain in their vehicles.

Hunters will drive separate vehicles when applicable to and from their assigned areas.

HIC's will wear gloves when inputting codes on keypads when utilizing badge to access through security gates. The HIC will need to use his badge for each vehicle in the party. (NO piggy backing through the gates.)

IAW MD State Seasons and daily legal hunting hours

BAG LIMITS

All game animals (except deer) bag limits are IAW Maryland harvest limits

(Note: Deer harvested at APG DO NOT count towards your MD State bag limits.

ASSIGNMENT OF HUNTING AREAS IF WEB HUNT TRAC IS INOPERABLE

FMWR will provide a fillable 1249 via e-mail to all HIC's with a copy of these GUIDELINES.

HIC's will request a hunting area by submitting a completed 1249 (with all members of hunting party) via e-mail to FMWR at usarmy.APG.imcom-fmwrc.list.usag-mwr-outdoorrec@mail.mil NLT 1 pm.

FMWR personnel will conduct a blind draw of the 1249's with support from CLE/DES.

Upon completion of each draw FMWR will provide a hunting roster of HIC/hunting party and assigned area to the hunters drawn, ATC range control, and CLE/DES NLT 5 pm.

To limit the amount of draws and range sheets being conducted there will be weekday areas, RDO Fridays, Saturdays, and Sundays. (HIC's will be assigned an area for multiple weekdays)

NON RDO week:

Monday & Tuesday - Draw conducted previous Friday and HIC will have area both days.

Wednesday, Thursday, & Friday – Draw conducted previous Tuesday and HIC will have area all three days.

Saturday & Sunday- Draw conducted previous Friday and HIC will have area for both days.

RDO week:

Monday & Tuesday - Draw conducted previous Friday and HIC will have area both days.

Wednesday & Thursday – Draw conducted previous Tuesday and HIC will have area both days. RDO Friday - Draw conducted previous Thursday and HIC will have area for the day.

Saturday & Sunday - Draw conducted previous Friday and HIC will have area for both days.
